Thank you for taking the time to read the following **Terms and Conditions**. Please read the following information carefully prior to signing and submitting the **Event Request Form**.

General Policies

A Child's Voice® Foundation welcomes special fundraising events sponsored by outside individuals and/or organizations. All events and promotions must be approved by the foundation ahead of time and meet the following criteria:

- Support the mission, vision and values of the foundation and its programs.
- Creates positive public awareness of A Child's Voice Foundation and its programs.
- Has monetary and other benefits to the foundation and its programs.
- For the event coordinator and volunteers to act as ambassadors of A Child's Voice® Foundation.

Liability and Planning

Liability and Indemnity

Organizer(s) of a third party fundraiser event held in benefit of A Child's Voice® Foundation and its programs shall assume any and all liability relating to or resulting from the event, shall hold harmless the Foundation and its directors, officers and employees from any and all claims arising out of or related to the fundraiser event.

Right of Refusal

A Child's Voice® Foundation reserves the right to refuse or relinquish involvement in any third party event that does not meet its approval. If the Foundation refuses or relinquishes involvement in any third party event, none of the logos, trade-marks or other intellectual property belonging to the foundation may be used in relation to that event.

Licences and Fees

Revenue and Donation Collection

Tax Receipting

A Child's Voice® Foundation is a registered charity and therefore is eligible to issue tax receipts. The Canada Revenue Agency has developed rules and regulations which the foundation must abide by in order to maintain its registered charity status.

A Child's Voice® Foundation may issue a tax receipt for pledges and donations of \$20.00 or more if we are provided with tax receipt forms that include the donator's name and address. The foundation **may not** issue tax receipts for the following:

- Cash sponsors of the event
- In-kind sponsors who donate products or services to the event

Marketing and Promotion

The foundation and its staff can not provide information on what prosthesis the hair will be used for or what child receives the prosthesis.
